- Last date of admission is 25/07/2019 by 04.00 P.M.
- 2. Original mark sheet, certificate, caste certificate should be produced at the time of admission.
- 3. Two sets of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any.
- 4. Two copies recent passport size photograph (colour).
- 5. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
- 6. Rules for uniform will be supplied at the time of admission.

#### Points to be noted:-

- 1. Residing in the hostel is compulsory for the male trainees.
- 2. There is no provision of hostel accommodation for the female trainees.
- 3. His/her name may be struck off from the roll even after admission for any of the following:
  - a. If he/she is medically unfit, Candidates suffering from congenital and contagious diseases.
  - b. Expecting mothers.
  - c. His/her conduct and behavior is unsatisfactory. If he/she does not obey the rules and regulations of the hostel and institute.
  - d. For fifteen (15) days absence from the starting of academic session.
  - e. If any certificate/mark sheet submitted by the candidate is proved false.

<sup>\*</sup>No student of other media of instructions than the language medium of the Institute as per the mediumwise list in the notification of Admission of the relevant session, will be evaluated.

<sup>\*</sup>Any violation of the norms and standard, set and spelt out in the guidelines, shall lead to cancellation of the admission.

<sup>\*</sup>Candidates, selected under Vocational Category cannot be transferred to 'non-vocational category' and vice-versa

<sup>\*</sup>Candidates under Management Quota, not over 10% of the sanctioned in-take in respect of only the Selffinanced Private Unaided D El Ed Institutes, should be listed out separately and forwarded to the Board online for approval in terms of notification to be issued for the purpose.

<sup>\*</sup> The Process of admission as per the given lists should be complete within seven days from the date of receipt of the provisionally approved merit lists.

<sup>\*</sup>And thereafter, a report of admission through our online system should be submitted to the Board for the next course of action.

<sup>\*</sup>In case the second, third or subsequent merit lists are approved by the Board, the admission in terms of those approved merit lists should be completed within four days from the date of receipt of such approved merit lists

<sup>\*</sup>Separate approval for conversion of vacant deputation-seats, reserved for primary school teachers, appointed before 03.09.2001, as per the given guidelines, is required.

<sup>\*</sup>In case of an Ex-Service-man-category applicant, his army-graduation-certificate should be treated at par with 45%/50%, as the case may be, in HS/ or its Equivalent examinations, for admission to the Course.

## Guidelines regarding use of Approved Merit Lists for Admission to Two Year D. EL ED. Course (Regular)—2019-2021

- 1. Having a rank in the Merit lists does not guarantee admission. Admission is strictly subject to passing the verification and authentication of the stated percentage of marks, date of birth, category, medium, academic qualifications, validity of Boards / Councils / Universities etc. with the original documents and testimonials.
- 2. For date of birth M.P. or its equivalent examination Admit Card/Certificate shall have to be verified in addition to verification of other documents uploaded by the applicant. The date of birth shall be recorded as in the M.P. or its equivalent examination Admit Card/Certificate. In case of difference the head of the institute may treat the application invalid.
- 3. If an applicant fails at any stage of such verification of details, her candidature will be cancelled by the authority of the Institution without referring the matter to the WBBPE for decision. The Institution authority will only forward a report of such cancellation to the Board.
- Right to being enlisted in the SC/ST/OBC-A/OBC-B/PH/EX-SERVICEMAN/IN-SERVICEMAN category is reserved for candidates belonging to such category/ies.
- All applicants for 4% (four percent) seats under Vocational Category shall, however, be considered as "UR", regardless of their categories.
- An enlisted candidate may be denied admission, if there is mismatch between the statements, made and the documents, produced at the time of admission.
- 7. No vocational category candidate is eligible for the seats of other categories.
- 8. Only prescribed fees are chargeable.
- Classes must be started immediately after the process of admission as per the First Listis complete, i.e. 22nd July, 2019 for the Session—2019-2021.
- Subsequent Lists may be released only, if seats remain vacant category-wise after the expiry of the last date of reporting for admissionin terms of the First List.
- 11. For subsequently listed candidates four working days from the date of receipt of the list/s should be given
- 12. Candidates suffering from congenital and contagious diseases should not be admitted.
- 13. Expecting mothers should not be admitted.
- 14. All the relevant testimonials should be forwarded to the relevant Board /Council for verification immediately after admission
- 15. The List of candidates admitted should be sent to the West Bengal Board of Primary Education immediately after admission process is over.
- 16. The provisionally approved merit lists of Management Quota candidates shall be sent afterwards on having the report from your end where the Management Quota candidates shall be identified by you.

The above guidelines must be walled up in the Institution in full view of all concerned for knowledge and information of all.
