- 1. Last date of admission is 12/12/2020 by 02.00 P.M.(Except Sunday And Govt. Holidays)
- Original mark sheet, certificate, M.P admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, ph certificate, ex-serviceman's certificate/ppo (whichever may be applicable for which category) should be produced at the time of admission.
- Two sets of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any.
- 4. Two copies recent passport size photograph (colour).
- 5. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
- 6. Rules for uniform will be supplied at the time of admission.
- Candidates are also requested to follow COVID-protocols like 'physical distancing', 'wearing masks', using hand-sanitizers while visiting institute for admission.

Points to be noted:-

- Residing in the hostel is compulsory for the male trainees.
