
**NOTIFICATION**

I am directed by the Secretary of WBBPE vide Order No.114(61)/WBBPE/D.El.Ed./33A-08/2023, dated-07/02/2024 to inform all concerned that the following candidates from unreserved wait merit list are hereby called for counseling against 8 (Eight) vacant seats (5 seats from in-service category and 3 seats from Ex servicemen category) on **16/02/2024 at 12.00 noon**.

It is also to be noted that the selection for admission against under table mentioned vacancy will be based on 'AS PER MERIT' criteria only among the present candidates on mentioned date and time.


1. Mere appearance in the counseling does not ensure seat for admission.
2. **Date of counseling is 16/02/2024, time: 12.00 Noon sharp.**
3. Candidates will be called up according to their position in merit list.
4. Counseling process will stop at the moment when vacancies are filled up. Thereafter no further candidate will be called in that category.
5. Admission will be finalized only after physical verification of all testimonials and submission of prescribed admission fees.
6. Downloaded Application Form shall be submitted at the time of admission.
7. Original H.S. mark sheet, Madhyamik admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, should be produced at the time of admission.
8. One set of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any, Aadhar Card, should be submitted at the time of admission.
9. Two copies recent passport size photograph (colour).
10. **Rs. 7700/- (Seven thousand and seven hundred only)** for the admission fees prescribed by the West Bengal Board of Primary Education have to be deposited by the candidate at the time of admission.
11. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
12. Rules for uniform will be supplied at the time of admission.
13. His/her name may be struck off from the roll even after admission for any of the following:-
  - a. If he/she is medically unfit, Candidates suffering from congenital and contagious diseases.
  - b. Expecting mother.
  - c. His/her conduct and behavior is unsatisfactory. If he/she does not obey the rules and regulations of the hostel and institute.
  - d. For fifteen (15) days absence from the starting of academic session.
  - e. If any certificate/mark sheet submitted by the candidate is proved false.
