Points to be noted:-

3. No candidate will be allowed to participate in the counseling, reported after reporting time.
4. Candidates will be called up according to their position in wait merit list.
5. Counseling will stop at the moment when vacancy/s is/are filled in. Thereafter no further candidate will be called.
6. Downloaded Application Form shall be submitted at the time of admission.
7. Original H.S. mark sheet, Madhyamik admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, should be produced at the time of admission.
8. One set of Xerox copies of Downloaded Application Form, H.S mark sheet, M.P certificate/admit card, caste certificate if any, Aadhar Card, should be submitted at the time of admission.
9. Two copies recent passport size photograph (colour & Lab print).
10. **Rs. 7700/-** (Seven thousand and seven hundred only) for the admission fees prescribed by the West Bengal Board of Primary Education and **Rs. 2000/-** (Two thousand only) as mess charges vide The Director, SCERT(WB) memo No. 898/F.No.386(Pt-2)/SCERT, Dt. 23/08/2022 have to be deposited by the candidate at the time of admission.
11. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
12. His/her name may be struck off from the admission register even after admission for any of the following:-
 - a. If he/she is medically unfit, candidate suffering from congenital and contagious diseases.
