

2. Original mark sheet, certificate, M.P admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, PH certificate, ex-serviceman's certificate/PPO (whichever may be applicable for which category) should be produced at the time of admission.
3. One set of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any.
4. Two copies recent passport size photograph (colour).
5. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
6. Rules for uniform will be supplied at the time of admission.
7. Candidates are also requested to follow COVID-protocols like 'physical distancing', 'wearing masks', using hand-sanitizers while visiting institute for admission.
