Points to be noted:-

1. Mere appearance in the counseling does not ensure seat for admission.
2. Reporting time **11:30 a.m** on the day of counseling.
3. Candidates will be called up category wise and according to their position in merit list.
4. Counseling in a particular category will stop at the moment when vacancy/s is/are filled in that category. Thereafter no further candidate will be called in that category.
5. Downloaded Application Form shall be submitted at the time of admission.
6. Original H.S. mark sheet, Madhyamik admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, should be produced at the time of admission.
7. One set of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any, Aadhar Card, should be submitted at the time of admission.
8. Two copies recent passport size photograph (colour).
9. Rs. 7700/- (Seven thousand and seven hundred only) for the admission fees prescribed by the West Bengal Board Of Primary Education have to be deposited by the candidate at the time of admission.
10. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
11. Rules for uniform will be supplied at the time of admission.
12. His/her name may be struck off from the roll even after admission for any of the following:-
 - a. If he/she is medically unfit, Candidates suffering from congenital and contagious diseases.
 - b. Expecting mothers.
 - c. His/her conduct and behaviour is unsatisfactory. If he/she does not obey the rules and regulations of the hostel and institute.
 - d. For fifteen (15) days absence from the starting of academic session.
 - e. If any certificate/mark sheet submitted by the candidate is proved false.
