1. **Date of admission is 24/10/2024 to 26/10/2024 by 12.00 P.M.**
2. Original mark sheet, certificate, M.P. admit card/certificate, Id proof (Aadhaar card, Voter Id or any valid document), caste certificate, P.H certificate,(whichever may be applicable for particular category) should be produced at the time of admission.
3. One set of self attested xerox copies of H.S. mark sheet, M.P. certificate/admit card, caste certificate, P.H. certificate if any and Aadhar card and Print copy of the online application form for admission should be submitted at the time of admission.
4. Recommendation letter & release order from the competent authority should be submitted for the In-Service/deputed teachers at the time of admission.
5. Photo copy of PPO should be submitted at the time of admission for the Ex-Servicemen candidate.
6. Three copies recent colour passport size photograph (Lab print).
7. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
8. Rules for uniform will be supplied at the time of admission.
9. This Institute is fully residential for male students.
10. Lunch for female students is compulsory.
11. Rs.2000/- (Two thousand) will be submitted at the time of admission for mess charge (vide Director, SCERT, W.B. order No. 898/F.No.386(Pt-2)/SCERT, dt. 23/08/2022).

Points to be noted:

- Her/his name may be struck off from the roll even after admission for any of the following:-
- a. If he/she is medically unfit, Candidates suffering from congenital and contagious diseases.
 - b. Her/his conduct and behavior is unsatisfactory. If he/she does not obey the rules or fifteen (15) days continuous absence from the starting of academic session.
 - c. If any certificate/mark sheet submitted by the candidate is proved false.
 - d. If She/he does not obey the attendance rules laid by the WBBPE i.e. 80% for theoretical classes and 100% for practical classes.
